5. Warsaw University of Technology does not intend to transfer your data outside the European Economic Area.

You have the right to access your personal data and the right to rectify it, the right to request deletion, processing restrictions, the right to transfer data (if the premise is consent to the processing of personal data), the right to object to data processing, the right to withdraw consent (if granted) at any time without giving a reason, without affecting the lawfulness of the processing that was carried out on the basis of consent before its withdrawal.
