## I. ZASADY REJESTRACJI NA STUDIACH STACJONARNYCH ANGLOJĘZYCZNYCH I STOPNIA OBOWIĄZUJĄCE OD R.A. 2021/2022

### REGULATIONS ON REGISTRATION FOR UNDERGRADUATE STUDIES IN FORCE SINCE 2021/2022

#### 1. Registration after the first semester

- Maximum number of ECTS credit points to be achieved during the first semester is **28**.
- A student who has obtained at least **20** ECTS points during the first semester can be registered for the second semester of study.

#### 2. Registration after the first year

- Maximum number of ECTS credit points to be achieved during the first year is **60**.
- A student who has obtained at least **40** ECTS points during the first year, and *has completed Calculus I and Algebra with Geometry, as well Calculus II and Theoretical Mechanics tutorial*, can be registered for the second year of study.

#### 3. Registration after the second year

- Maximum number of ECTS credit points to be achieved during the whole two years of study is **120**.
- A student who has obtained **60** ECTS points from the first year of study and at least **40** ECTS points during the second year and *has completed Strength of Materials I* can be registered for the third year of study.

#### 4. Registration after the third year

- Maximum number of ECTS credit points to be achieved during whole three years of study is **180**.
- A student who has obtained **120** ECTS points from the first and second year of study and at least **30** ECTS points during the third year can be registered for the fourth year of study.

Qualification for the list of diploma specializations takes place during the sixth semester on the basis of a ranking list created on the basis of the declaration of preferences for choosing a specialization and the weighted average of the grades for five semesters. Groups in specialties are created under the Dean's decision depending on the number of applicants and organizational possibilities.

After selecting the diploma specialization the choice of courses with elective versions is made and entries to the promoters are made.

Students who fulfill abovementioned requirements are qualified to the field practice performed during 8<sup>th</sup> semester of the study program.

#### 5. Registration after the fourth year

Maximum number of ECTS credit points to be achieved during whole four years of study is **225**. A student who has obtained **185** ECTS points from the first, second and third year of study can be registered for the fifth year of study.



- Registration takes place after 8 semester for retaken the 7th semester, and after the 7th repeated semester for retaken the 8th semester.
- In the case of retaking the year earlier than after the 8th semester, the student is obliged to complete all courses from the retaken year and from all previous years.

**Total result of Undergraduate Program is equal to 225 ECTS credit points** including 12 ECTS for field practice.

A three-month long obligatory field practice is held during 8<sup>th</sup> semester and completed gives 12 ECTS credit points.

Studies can be extended by three months for completing the Diploma Thesis.

Registration for the following course requires passing the required course:

## **II. ZASADY REJESTRACJI NA STUDIACH STACJONARNYCH ANGLOJĘZYCZNYCH II STOPNIA OBOWIĄZUJĄCE OD R.A. 2021/2022**

### **REGULATIONS ON REGISTRATION FOR GRADUATE STUDIES IN FORCE SINCE 2021/2022**

#### **1. Registration after the first semester**

Maximum number of ECTS credit points to be achieved during the first semester is 30. A student who has obtained at least 8 ECTS points during the first year can be registered for the second semester of study.

#### **2. Registration after the first year**

Maximum number of ECTS credit points to be achieved during the first year is 60. A student who has obtained at least 40 ECTS points during the first year can be registered for the second year of study.



### **3. Registration after the third semester**

Maximum number of ECTS credit points to be achieved during the whole three semesters of study is 70.

- Registration for the fourth semester of studies as a retake of the second semester is possible only in justified cases under the Dean's decision.
- Registration for the fifth semester of studies as a retake of the third semester is possible only in justified cases under the Dean's decision.

Studies can be extended by three months for completing the Diploma Thesis.
